

## "Would you like to become pregnant in the next year?"

Improving Maternal and Child Health

One Key Question® (OKQ) is a groundbreaking and simple service to help encourage primary care providers and others to routinely ask women about their reproductive health needs. By asking: "Would you like to become pregnant in the next year?" clinicians and others can more fully support women's health needs such as preventing an unintended pregnancy or preparing for a healthy pregnancy.

OKQ is designed to proactively address the root causes of unintended pregnancies, poor birth outcomes, and disparities in maternal and infant health. OKQ is focused on understanding women's intentions and providing follow-up care based on her response to the one key question. It is non-judgmental and equally supports women who want to become pregnant, those who do not, and those who are unsure or would be open to pregnancy. OKQ is used in a variety of settings, from home visiting, to primary care, to other innovative locations, such as food assistance programs and dental offices. Power to Decide has exclusive rights to all OKQ activities, trainings, agreements, and licenses.



## **Training and consulting**

OKQ training and consulting is offered in two essential packages:

Many locations nationwide are already using the OKQ program and Power to Decide hopes to expand on this number in the future. OKQ has been endorsed by more than 30 prominent national organizations, including the American Public Health Association, the American College of Obstetricians and Gynecologists (Committee opinion), and the National Association of Nurse Practitioners in Women's Health.

#### **Training and Certification**

Power to Decide will provide a 1 day, in-person certification training and consultation package for clinics, community-based organizations, public health departments, and other organizations well-suited for OKQ implementation. As a result of this training, participants will be able to implement OKQ with fidelity which includes developing the clinical pathways needed to ensure women have access to the most appropriate clinical care and other support services based on her response. Each training can accommodate up to 50 people per training and costs are determined based on the number of individuals. This package includes:

- Provider and Patient Materials
- Five hours of consulting (prior to and following training)
- Post training webinar
- Provider OKQ Certification (two years for the price of one)
- Access to a OKQ Provider Portal (only available to certified providers)

### **Systems Integration**

Power to Decide will work with systems—health care, hospital, public health, insurance, etc.— to integrate OKQ at the system and clinic (or site) level. Power to Decide will provide technical assistance and training throughout this year-long process to assist sites through a six-step quality improvement process to assess use of best practices, develop an action plan, measure and evaluate outcomes, and celebrate success. This package includes the Training and Certification (see above) package to ensure all providers are certified. In addition, sites will become OKQ Certified. This more expansive model includes:

- Training and Certification Package (see above)
- Yearlong technical assistance and training
- Access to the Systems Integration Online Portal
- System OKQ Certification

#### Costs

The cost of training and certification are based on the number of individuals being trained.
